Bid opening will be held at School #1, in the All Purpose Room, 32 Stevens Ave. Little Falls, NJ, at which time and place bids will be opened and read in public.

Submission of Original Bid and One Copy of the Bid

All bids are to be submitted in duplicate; one (1) original; one (1) copy

The **last day for questions** will be **May 22 at 4:00 p.m.** There will be a **pre-bid meeting** on **May 17 at 10:00 a.m.** While attendance is not mandatory, all prospective bidders are strongly encouraged to attend this important meeting, which will be held at Little Falls School #1 32 Stevens Ave, Little Falls, NJ 07424.

All bidders are required to comply with the requirements of the Law against Discrimination (N.J.S.A. 10:5-31 et seq.), and the Affirmative Action Rules (N.J.A.C. 17:27-1.1 et seq.). An Initial Project Workforce Report will be required from the successful contractor. (Form AA-201).

Contractors bidding on this project are to comply with the requirements of the New Jersey Prevailing Wage Act pursuant to N.J.S.A. 34:11-56.25 et seq.

A bidder on a public works project for a Board of Education where the cost of the work exceeds \$20,000.00 must first have been qualified by the Department of the Treasury, Division of Property Management and Construction, pursuant to N.J.S.A. 18A:18A-27 through 33, and shall submit with his/her bid a Prequalification Affidavit-No Material Adverse Change, a copy of a valid and active NOTICE OF CLASSIFICATION, a certified copy of a Total Amount of Uncompleted Contracts Form and such Affidavit that subsequent to the latest such statement submitted by him/her, there has been no material adverse change in the qualification information except as set forth in said Affidavit

Each bid shall be accompanied by a bid bond, cashier's check or certified check made payable to the Little Falls Board of Education, for ten percent (10%) of the amount of the total bid, however, not to exceed \$20,000.00.

Bidders are required by law to submit a Statement of Ownership Disclosure form statement setting forth the names and addresses of all persons and entities that own ten (10%) percent or more of its stock or interest of any type at all levels of ownership.

All contractors named in this proposal, shall possess a valid Public Works Contractor's Registration Certificate pursuant to N.J.S.A. 34:11-56.48 et seq., at the time the proposal is received by the Board of Education.

The bid package will also include other documents that must be completed and returned with the bid. Failure to comply with Instructions to Bidders and to complete and submit all required forms, may be cause for disqualification and rejection of the bid.

The Board of Education reserves the right to reject any or all bids pursuant to N.J.S.A. 18A:18A-18, 18A:18A-2(s), (t), (x), (y), 18A:18A-4(a-c), 18A:18A-22, and to waive any informalities that may be in the best interests of the board of education.
